CONVOCATION PERTH 1998

An enthusiastic gathering of 160 Fellows and their guests gathered at the Hyatt Regency in Perth for the Convocation held on Friday 13th March 1998 prior to the 29th Australian Dental Congress.

32 new Fellows were inducted into the College at a very impressive ceremony presided over by Don Heffron - our retiring President.

At the conclusion of the ceremony, Don inducted Geoff Hall from Adelaide as President for the next triennium 1998 - 2001. Geoff in his turn introduced his new officers and board of Regents. Their addresses and the Triennial Report by the Registrar Dr. Rob Butler are reproduced for the benefit of the many fellows who were unable to attend. The ceremony was followed by an excellent luncheon with great fellowship.

PRESIDENTIAL ADDRESS

The International College of Dentists is not new and I would like our new fellows and their guests to know something of its origins.

It was formed in 1920, 78 years ago, and subsequently incorporated with the full approval of the major World Dental Associations and the FDI in 1928.

Initially Australians were fellows of the American Section until an Australian Section was authorised in 1963 and formally inaugurated in 1967 by the then World President Dr. Gordon Agnew. Ten years later the name was changed to become the Australasian Section to incorporate New Zealand, New Guinea, Fiji and other small South Pacific Countries.

Apart from our recent activities the College seeks areas of need where we can provide assistance in furthering the goals of good dentistry. Over the years assistance has been given to Dental Libraries. We have provided Dentists to present special courses in South Pacific Islands, Northern Territory, and Tasmania. We have assisted in student exchange programmes, National Conventions of the D.A.A. and we always contribute to the Scientific Programme at each of the National Congresses of the A.D.A.

I urge you to read the history summarised in our publication "Know your College". A history of our Australasian Section has been approved and hopefully will be published in the near future. For this we are indebted to several contributors but primarily to Ken Sutherland and Gordon Rowell with the final editing by our Registrar.

Once a year there is a meeting of the Central body which our International representative Syd Dobbin attended. It was gratifying when he was made a "Master" of the College in 1996 and last year he was elected to the position of Vice President. We may have our second World President in the near future.

During my Presidency, Fellow Regents have fulfilled their obligations with honour. Peter Ryan from Queensland, Tom Speed of New Zealand and Spiro Halikis from Western Australia have served for several years in various capacities and always unselfishly on behalf of the College - I thank them for their years of service and wish them the very best for their future. Neil Henry has been responsible for the production of our Newsletter for the past three years, and Bill Chalmers our everlasting Treasurer continues to manage our finances with enthusiasm.

Our section has no permanent office and staff, so the overall responsibility for maintaining the ongoing weekly functions fall on the Registrar's shoulders. Rob Butler's constant help during my Presidency was fabulous. For the edification of our Fellows from around Australia and beyond we are International because we are founded on criteria that in our profession are universal. We ensure it remains so by accepting only those who meet the worldwide precepts of our College and accept the future obligations attached thereto. All our Inductees can be justifiably proud to have met these precepts.

On graduation some Dentists assume it is the end of their achievements - for our new fellows graduation was but a beginning to face many new challenges ahead and our inductees did just that and they have the will to conquer them. With the acceptance of Fellowship today, your peers have recognised your past achievements (which are very briefly summarised in this Newsletter) but they also expect your leadership in dentistry and in your community to continue.

The Section has also pledged \$500 sponsorship to the Dental Assistants Association of Australia to assist them in conducting educational activities in conjunction with the Perth Congress. Similar assistance was given at the Hobart Congress in 1995 in sponsoring CPR training.

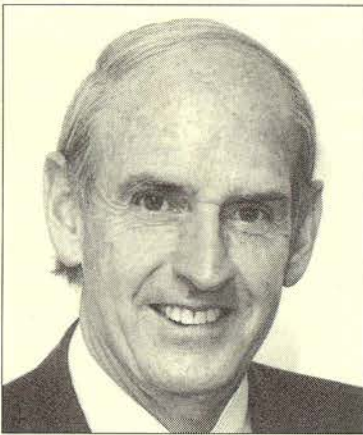
An annual subscription to the Australian Dental Journal is provided to the Dental School in Fiji and it has also been supplied with educational equipment, for which grateful acknowledgment has been received. Reference books have also been forwarded to this School. In addition, further assistance has been provided to the Fiji School by way of donation of curing lights and sponsoring of a visit to the School by Fellow Dr. John McIntyre.

Following previous sponsorship of undergraduate exchange between Adelaide and Hong Kong schools, the Board of Regents of the College approved a grant of \$1000 to assist the initiation of a similar programme of exchange between undergraduates of Sydney and Singapore. Fellow John Booth of Adelaide has been the driving force behind these excellent initiatives. Encouraging reports have been received from the participating students.

Dental equipment for Tonga has been purchased and transported by Sydney dental undergraduates who travelled there as part of an elective project. They report that the equipment has been put to good use in the local hospital. The College is continuing to explore further opportunities to aid our colleagues in the Pacific area with sponsored lecture tours and provision of educational material and clinical equipment.

It is a great honour to have been elected President of the Australasian Section, and I must thank my fellow Regents for giving me the opportunity to serve in this capacity.

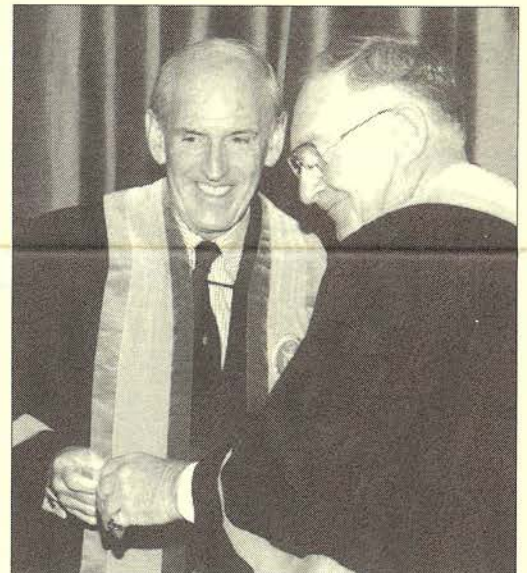

NOTES FROM THE BOARD OF REGENTS' MEETING

A meeting of the Board of Regents of the Australasian Section of the College was held in Perth on 12 March 1998.

Fellows may be interested in the following items from this meeting:

- Several changes were made to the By-Laws in order to ensure an even spread of Regents covering the Australian States and New Zealand. The effect of these changes is that, in future, the Board must include at least one Regent from each of New Zealand, New South Wales, Queensland, South Australia, Victoria and Western Australia. This has, in fact, been practised for some time but was not enshrined in the By-Laws. The Registrar now also becomes an ex-officio member of the Board, thus allowing for an extra Regent position.
- The Section now has a membership of 389, including 113 Life Members, 1 Honorary Life Member and 1 Honorary Member.

Life Membership has been granted to the following, who have satisfied the relevant Constitutional requirements : R. Setright, M Sims and M Seymour. The Registrar reported that he has a stock of ties which were available for sale at a price of \$25. Fellows who wished to purchase a tie could contact him c/o the ADA Federal office.

- The Board resolved to maintain the annual subscription at the present level although it was noted that some elements of the amounts payable to the headquarters in the USA had increased. The current charges, applicable to new Fellows were as follows:

- The Board was conscious of the need to provide opportunities for Fellows to meet and also of the requirement for conducting more frequent Induction Ceremonies for new Fellows. There will be an Induction and Luncheon in conjunction with the NZDA meeting in Wellington on Friday 28 August 1998.
